### Welcoming One Another

The Apostle Paul writes in Romans 15:7: *Welcome one another, therefore, as Christ has welcomed you, for the glory of God.*

This New Year offers us many opportunities to welcome people in new ways. St. Paul says to welcome one another just as Christ has welcomed you. Jesus was known for eating with tax collectors and others who were not welcome in the usual circles. So how do we do the same?

*Philoxenia* is the Greek New Testament word for hospitality or "love of the stranger." *Philo* means brotherly or sisterly love. *Xenia* is almost always translated as "guest-friendship." Combine the two and you have an attitude that overcomes xenophobia—the "fear of the stranger" is overcome with the "love of the stranger" or *philoxenia*.

So this leads to an interesting discussion about the security system we put on our church doors last summer. Are we being xenophobic or properly careful about limiting access to our church? In today's society having open access into public buildings is not advised. But how do we welcome strangers without taking undue risks?

Let me offer some suggestions. Practicing *philoxenia* can happen when we chat with strangers after worship, at the grocery or hardware store, or even at places like the ski slopes or bowling alley. I was able to catch up with a banker from Yankton I hadn't seen in a decade at Terry Peak last winter. But I do admit I had to cheer against his wide receiver son who plays for the Yankton Bucks when the Scoopers played them in football last fall!

I have talked with a lot of strangers over the years and I like reconnecting with those I have not seen in a long time. I try to welcome others as Christ has welcomed me. I hope you will join me in doing that this New Year. It might be the gracious hospitality gift we can share with others to show forth the love of Christ in our hearts.

We thank Robin Baldwin for her dedication to this committee for many years. The committee's chief duty is to plan, lead, and implement worship and the music ministries of the congregation. Often, we find our committee involved in many other duties at the church so dedicated is the best word to describe this very busy committee.

**MUSIC:** Our weekly musicians are a blessing to the services. Dan Chapman, Candy McKay, Danilee Pudwill, Marcia Potts, and Christian and Marlene Kotab lead the music on Sundays and Wednesdays. Soloists, the children, and the Adult Choir all contribute to the wonderful music ministry. It is inspiring to see the children and adults lead the Palm Parade on Palm Sunday. Lynette Kvanvig and Marie Ritten are our substitute accompanists and Gary Meyer is always willing to add his poetic and thoughtful songs to enhance the worship experience. ## 2025 Evangelism Committee Annual Report

We learned the L.A.S.S.I.E. Approach. We also learned how to find out if a person was a head, heart or hands person. We need to keep these in mind when talking to people. Head: Their focus is on Truth. Heart: Their focus is on Hope. Hands: Their focus is on Purpose.

Listen to determine how to connect and communicate with people

Ask basic, exploratory, challenging, open-ended questions to get and keep the conversations going.

Seek opportunities to connect with the person such as sports, illness or anything to give a person a starting point to connect with

Share God's word, share the faith. Keep it about God. Find ways to tell Jesus' story. The spirit will guide you. We generously plant and water and God grows. We need to plant the seed, then the rest in in God's hands. 1 Corinthians 3: 6-7.

Invite them to an event going on in the church, keep the invite simple; it can be an invite to a worship service on Sunday morning.

Encourage one another, we are working on bringing the good news of Jesus. Encourage through prayer either with them or for them. Prayer is a great witness. Most people appreciate praying for them even if they do not know Jesus.

Second part of the year we are reading and going over the book "A Changing World". A few of the events we did this past year: we held a coffee and donut event; root beer floats a couple of times. We weathered the cold and handed out or left door hangers on people's doors to inform/invite them to the different Christmas events that were happening.

Moving forward to this year, roof leaks in the Sanctuary continue to be a problem, the consensus being that a major fix may be in order to alleviate this and this will require more discussion and planning. There are still things that are left on our list and these will be taken care of as time allows in order of importance.

Grace and peace to you in Christ's name! This year reminded me that the Church is always a blend of plumbing and poetry. The steady, unseen pipes that keep ministry flowing, and the surprising grace that breaks in when we least expect it.

And together, across South Dakota, you lived both.

Because of your faithfulness:



- The **\$1.1 million** Lilly grant continues to strengthen rural ministry through an expanding rural ambassador program and brings learning to your recliner at home through Pasque (<http://www.sdsynodlearns.org/>). Synod Authorized Ministers (SAMs) experience intentional community with peers, and seminarians get to experience rural ministry through a paid immersion program.
- **1/4** of all SD Synod congregations have received a STAR (Small Town and Rural) grant through funds raised in SD for South Dakota congregations. These grants have helped to cover unexpected expenses across our synod.
- **\$1.3 million** supports children and families through the "Holy Playground" Initiative, reminding us that every child deserves to flourish.
- **Micro-grants** to alleviate hunger in our communities have been a tangible way to multiply Christ's compassion, feeding the stranger, stocking shelves, warming homes, and empowering congregations to respond in real time.
- **New pastors, deacons, and lay leaders** stepped into their callings, shaped by your encouragement and the Spirit's persistence.
- **Congregations in transition** found guidance, courage, and companions on the path.
- **Partnerships with Native, immigrant, and global communities** deepened our witness and expanded our imagination for what the body of Christ looks like.



These are numbers and facts, yes, but behind every number is a story, a face, a kitchen table, a worshiping community, a moment when the Gospel became flesh again in South Dakota and across our world.

And that is the poetry.

Thank you for granting me the gift of serving another six-year term as your bishop. I receive it with humility and with deep gratitude for the trust you place in me. The work before us is honest and holy, and the Spirit is already ahead of us.

As we enter a new year, may we continue to be a synod that holds plumbing and poetry together, a church grounded enough to meet the needs of today, and bold enough to imagine what God can do next.
